### **Admission rules (2025-2026)**

1. All candidates seeking admission in B.A. Part 1 and B. Com Part 1 class have to appear in CUET (B.A.) and CUET (B.Com.) test 2024 for admission in B.A. and B. Com. The admissions shall be made on the basis of merit in CUET (B.A.) and CUET (B. Com) entrance test conducted by the National Testing Agency (NTA).
2. Admissions will be done on the basis of merit till the availability of seats.
3. The candidate will be required to present themselves in person for the counseling and admission on the notified date/time and place.
4. The Non-CUET candidates may get admitted if the University of Allahabad permits the Constituent Colleges to give admissions under Non-CUET category as well.

#### **4. RESERVATION AND SPECIAL CONSIDERATION / QUOTA**

- (i) 15% of the total seats for the Scheduled Caste (SC) category, 7.5% of the total seats for Scheduled Tribe (ST) category, 27% of the total seats for Other Backward Caste (OBC) category shall be reserved for candidates belonging to these category, all certificates are on the central Government format.
- (ii) 10% of the total seats shall be reserved for candidate belonging to EWS category.

#### **5. Sports Quota-** 2% of the total seats in shall be allotted under Sports Quota.

6. Admission under separate quota will strictly be on the basis of merit list provided by the advisory committee, Sports Board.

#### **7. Person with Disability (Divyang):**

5% of total seats for this course will be available for person with disability who can pursue this course without any difficulty. 1% with benchmark disability under clauses (d) and (e) namely:

- a. Blindness and low vision.
- b. Deaf and hard of hearing.
- c. Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy.
- d. Autism, intellectual disability, specific learning disability and mental illness.
- e. Multiple disabilities from amongst person from clauses (a) to (d).

#### **NCC Weightage:**

A weightage of 5% shall be added to the score obtained by the candidate holding NCC 'B' certificate in the Admission Test / Entrance Test.

## **Documents to be presented at the Time of Admission**

1. High-school or equivalent examination mark sheet and certificate in original along with its self-attested photocopy.
2. Intermediate or equivalent examination mark sheet and certificate in original along with its self-attested photocopy.
3. Original Transfer Certificate/Migration Certificate for regular candidates at the Qualifying Examination/ affidavit duly attested by a Notary/Public Commissioner for private candidates at the Qualifying Examination.
4. Admit Card issued by the University/NTA.
5. Score Card of CUET.
6. Claiming weightage /premium/special Consideration:
  - i. For SC/ST, OBC and EWS category candidates governed by Rule 1.1, 1.2 and 1.3 :
    - a. For SC/ST category candidates recent caste certificate (original and photocopy)
    - b. For OBC candidates recent Caste certificate on Central Government format indicating Non-creamy layer is a must and any other certificate if required. ( original and photocopy)
    - c. For EWS candidate, EWS certificate on Central Government format. ( original and photocopy)
    - d. For the applicants Kashmiri Migrants category: Original and a photocopy of the certificate issued by competent authority for Kashmiri Migrants.
    - e. For the applicants holding NCC 'B' Certificate: Original and a photocopy of the NCC 'B' certificate.
    - f. For the applicants of Sports quota: Original and photocopy of the certificate in support of outstanding contribution in sports at National Level and State Level. For this the candidate will be interviewed by the Board organized by the Athletic Association at the time and place announced by it.
    - g. For the applicants of Divyang quota: Original and a photocopy of the certificate of Physical Disability (Visual, Hearing, Orthopaedic) issued by the Chief Medical officer of a District Hospital or by the Viklang-Kendra, Prayagraj and to appear before a Board of Doctors to assess the intensity of disability/challenge on a date and place given by the college.
    - h. Income certificate of the parent/guardian, issued by the competent authority/ officer in case if Annual / Family Income have a consideration for any claim of the candidate.
    - i. A copy of online filled anti- ragging certificate will be required at the time of admission.
    - j. For detail information see CUET brochure of University of Allahabad.

**Note:** The college may cancel the candidature of such applicants who furnish incomplete or false or misinformation or conceal the facts in online registration form.

इलाहाबाद विश्वविद्यालय शैक्षणिक वर्ष 2025-2026 के लिए CUET (UG)-2025 प्रवेश परीक्षण के माध्यम से 16 स्नातक पाठ्यक्रम प्रदान कर रहा है। CUET वेबसाइट (<https://cuet.nta.nic.in>) के माध्यम से CUET (UG)-2025 आवेदन पत्र को भरने से पहले पाठ्यक्रम विवरण, पात्रता और अन्य विवरणों की जाँच की जानी चाहिए।

1. पंजीकरण अवधि: CUET (UG)-2025 के लिए पंजीकरण 1 मार्च से 22 मार्च, 2025 तक खुला है।
2. आवेदन सबमिशन: उम्मीदवारों को आधिकारिक वेबसाइट <https://cuet.nta.nic.in> के माध्यम से अपने आवेदन जमा करना होगा।
3. आवेदन शुल्क भुगतान: आवेदन शुल्क का भुगतान 23 मार्च, 2025 (11:50 बजे) तक किया जाना चाहिए।
4. एप्लिकेशन सुधार विंडो: सुधार विंडो 24 मार्च से 26 मार्च, 2025 तक उपलब्ध होगी।
5. परीक्षा की तारीखें (टैटेटिव): CUET (UG)-2025 परीक्षा 8 मई और 1 जून, 2025 के बीच आयोजित की जाएगी।
6. परीक्षा मोड: परीक्षा कंप्यूटर-आधारित परीक्षण (सीबीटी) मोड में आयोजित की जाएगी।
7. संचार: सुनिश्चित करें कि पंजीकरण के दौरान प्रदान की गई ईमेल आईडी और मोबाइल नंबर मान्य और सक्रिय हैं, क्योंकि एनटीए से सभी संचार ईमेल या एसएमएस के माध्यम से भेजे जाएंगे।
8. विषय चयन: उम्मीदवार भाषाओं और सामान्य योग्यता परीक्षण सहित अधिकतम पांच (05) विषयों का चयन कर सकते हैं। CUET UG-2025 जानकारी बुलेटिन को अधिक विवरण के लिए देखें (<https://cuet.nta.nic.in/information-bulletin/>)।
9. हिंदी या अंग्रेजी और सामान्य योग्यता परीक्षण इलाहाबाद विश्वविद्यालय में सभी यूजी पाठ्यक्रमों में सभी उम्मीदवारों के लिए अनिवार्य है। एक विशेष यूजी पाठ्यक्रम के लिए विशिष्ट विषय चयन CUET वेबसाइट (<https://cuet.nta.nic.in>) पर जांचा जा सकता है।
10. इस शैक्षणिक सत्र से, भाषा (अंग्रेजी/हिंदी) और सामान्य योग्यता परीक्षा के अतिरिक्त, संबंधित कार्यक्रम की मेरिट तैयार करने के लिए केवल एक डोमेन विषय पर विचार किया जाएगा।
11. विभिन्न यूजी पाठ्यक्रमों के लिए कार्यक्रम विशिष्ट विषय आवश्यकता और पात्रता मानदंड तालिका 1 और तालिका 2 में दिए गए हैं।
12. अंकन योजना: सही उत्तर के लिए: 05 अंक (पांच)। 01 (एक) चिह्न के प्रत्येक गलत उत्तर के लिए नकारात्मक अंकन होगा।
13. प्रश्न पैटर्न और अवधि: प्रत्येक परीक्षण पत्रों के लिए कुल 50 प्रश्न। सभी प्रश्न अनिवार्य हैं। प्रत्येक टेस्ट पेपर के लिए अवधि 60 मिनट होगी।
14. उपरोक्त जानकारी संशोधन के अधीन है। उम्मीदवारों को नियमित रूप से CUET (UG)-2025 वेबसाइट (<https://cuet.nta.nic.in>) की जांच करने का सुझाव दिया जाता है।

The University of Allahabad is offering 16 Undergraduate courses through Common University Entrance Test (CUET) for Undergraduate (UG) courses for the academic year 2025-2026. The course details, eligibility and other details must be checked before filling the CUET (UG)-2025 application form through CUET website (<https://cuet.nta.nic.in>).

1. **Registration Period:** The registration for CUET (UG)-2025 is open between March 1 and March 22, 2025.
2. **Application Submission:** Candidates must submit their applications via the official website <https://cuet.nta.nic.in>
3. **Application Fee Payment:** The application fee must be paid by March 23, 2025 (11:50 PM).
4. **Application Correction Window:** The correction window will be available from March 24 to March 26, 2025.
5. **Examination Dates (Tentative):** The CUET (UG)-2025 exam will be conducted between May 8 and June 1, 2025.
6. **Exam Mode:** The exam will be conducted in Computer-Based Test (CBT) mode.
7. **Communication:** Ensure that the email ID and mobile number provided during registration are valid and active, as all communication from the NTA will be sent via email or SMS
8. **Subject selection:** Candidates may choose up to a maximum of five (05) subjects including languages and General Aptitude Test. Check the CUET (UG)-2025 information bulletin for more details (<https://cuet.nta.nic.in/information-bulletin/>).
9. **Hindi or English and General Aptitude Test are compulsory for all candidates across all UG courses in the University of Allahabad. Subject selection specific to a particular UG course can be checked on the CUET website (<https://cuet.nta.nic.in>).**
10. **From this academic session, in addition to language (English/Hindi) and general aptitude test, only one domain subject shall be considered for preparation of merit of respective programme.**
11. Programme specific subject requirement and eligibility criteria for various UG courses are given in Table 1 and Table 2.
12. **Marking Scheme:** For Correct Answer: 05 marks (Five). There will be negative marking for each incorrect answer of 01 (one) mark.
13. **Question pattern and duration:** Total 50 questions for each test papers. All Question are compulsory. Duration for each test paper would be 60 minutes.
14. The above information is subject to modification. The candidates are suggested to check the CUET (UG)-2025 website (<https://cuet.nta.nic.in>) regularly.

**Note (Specific eligibility criteria):**

1. An applicant who has passed or appeared in any stream of the Intermediate Examination conducted by the U.P. Board/C.B.S.E./I.C.S.E. or an examination by any State Board. The equivalence as defined in University Ordinances-2008 or by UGC Regulations as decided from time to time thereto is eligible to apply for the Undergraduate course for the academic session 2025-2026.
2. An applicant who has passed or appeared at the Intermediate examination with Art group, Science group or Commerce group is eligible to apply for B.A.
3. An applicant who has passed or appeared at the Intermediate examination with Science Group (Maths groups) is eligible to apply for the B.Sc. (Maths group) and with

the Science Group (Bio Group) is eligible to apply for B.Sc. (Bio group).

4. The candidate who has passed or appeared in the Intermediate examination with Commerce stream or Science stream will be eligible for admission to B.Com.
5. For BA (Music)/B.P.A application forms of only those candidates would be considered who have Music as one of the subjects at Intermediate level or they have passed an equivalent examination in Music from a recognized Institution.
6. Only such female applicants are eligible to apply for Five year Integrated course in Family and Community Science (Home Science), who have passed or appeared at the Intermediate Examination conducted by the U.P. Board/C.B.S.E./I.C.S.E. or an examination equivalent either with
  - Science Group, or
  - With any other Group having Home Science as one of the subjects after having passed the High School (or equivalent) examination with Science Group.
7. For B.A. (Urdu) application forms of only those candidates would be considered who have Urdu as one of the subjects at Intermediate level or they have passed an equivalent examination in Urdu from a recognized Institution.
8. For B.A. (Geography) application forms of only those candidates would be considered who have Geography as one of the subjects or have science at Intermediate level or they have passed an equivalent examination in from a recognized Institution.
9. The admissions shall be made on the basis of merit in CUET (UG) - 2025 and Practical test of the Department (Department of Visual Arts) in the University of Allahabad. Applicant shall be required to appear in both Practical & CUET (UG) - 2025.

#### **RESERVATION AND SPECIAL CONSIDERATION / QUOTA:**

- A.** In accordance with provision of Section 9 of the University of Allahabad Act, 2005 (Act No. 26 of 2005) seats shall be reserved for Scheduled Caste (SC), Scheduled Tribe (ST) and Other Backward Classes (OBC) category candidates in all subjects / course for which the Admission Test has been held, as given here under:
- (i) 15% of the total seats in each subject / course shall be reserved for candidates belonging to Scheduled Caste (SC) category;
  - (ii) 7.5% of the total seats in each subject / course shall be reserved for candidates belonging to Scheduled Tribe (ST) category; and
  - (iii) 27% of the total seats in each subject / course shall be reserved for candidates belonging to Other Backward Caste (OBC) category.
  - (iv) In case the seats reserved for Scheduled Tribe (ST) category candidates remain vacant on account of non-availability of candidates the same shall be filled by the candidates of Scheduled Caste (SC) candidates.
  - (v) 10% of the total seats shall be reserved for candidate belonging to EWS category.

**B. Kashmiri Migrants:**

Weightage as per Government of India guidelines shall be given to Kashmiri Migrants. In order to avail this weightage, the candidates shall have to present a certificate to this effect from an officer of the Ministry of Education not below the rank of Joint Secretary or equivalent.



**C. Foreign Nationals/NRI:**

Foreign Nationals shall be required to apply through International Students Advisor in accordance with the procedure laid down by the University of Allahabad. The candidate in this case shall not be required to appear in the Admission Test / Entrance Test, but shall be considered for admission on the recommendation of a committee constituted for the purpose, which shall examine the academic credentials and certificates of the candidate before making any recommendation.

**D. Sports Quota:**

2% of the total seats in each subject/ course shall be allotted under Sports Quota.

**E. Person with Disability (Divyang):**

- (i) As per section 32(1) of the Rights of Persons with Disabilities Act, 2016, all Government institutions of higher education and other higher education institutions receiving aid from the Government shall reserve not less than **five (05) per cent** seats for person with benchmark disabilities. Therefore 5% of total seats for this course will be available for person with disability who can pursue this course without any difficulty.
- (ii) A candidate who has a certified disability of not less than 40 % in any limb or in orthopaedic structure which, in the opinion of the Medical Board (constituted by the University of Allahabad), amounts to an overall physical handicap of not more than 70% or is a certified Visually impaired or a Hearing impaired, may be admitted to the concerned course / subject, irrespective of his position in the order of merit of the total aggregate score, on the recommendation of the Medical Board.
- (iii) Seats under this quota shall be filled in order of preference given below. One percent each shall be reserved for person with benchmark disability under clause (a), (b) and (c), and one percent with benchmark disability under clauses (d) and (e) namely.
  - a. Blindness and low vision.
  - b. Deaf and hard of hearing.
  - c. Locomotor disability including cerebral palsy, leprosy cured dwarfism, acid attack victims and muscular dystrophy.
  - d. Autism, intellectual disability, specific learning disability and mental illness.
  - e. Multiple disabilities from amongst person from clauses (a) to (d).
- (iv) The privilege shall not be given except claimed by the candidate at the time of application. At the time of admission, the candidate shall be required to produce a certificate issued by the Chief Medical Officer of the appropriate District or by the Viklang Kendra, Allahabad, which testifies to his disability and bears an attested photograph indicating his / her disability clearly.
- (v) All candidates entitled to be admitted under the above quota to a course shall be adjusted against their respective social category.

**F. Teacher/Employee Ward Quota:**

After the completion of admission on the sanctioned seats in each course of study, the wife/husband, sons and daughters of regularly appointed serving and retired teachers /

employee of the University, the University Institutes, the constituents Colleges and constituents Institutes which we shall call unit hereafter, who produce relevant certificate duly signed by the Registrar in case of University, the Director in case of University Institutes, the Principal in the case of constituent Colleges (units) and the Director in case of constituent Institutes shall be admitted, on the basis of their relative scores against 5% supernumerary seats (with a minimum of one seat) in each course of study, only in the unit in which such Teachers/Employees are serving or from where they have superannuated.

Provided that in case seats remain vacant in a course in the unit, these will be filled by the wards of the employees of other units,

- ii. It is clarified that the unit mentioned in clause (i) means the University/Constituent Colleges of the University.
- iii. Teacher/Employee Ward benefit will be granted only when the candidate has made such a claim in the Application Form and presents the required documents and certificates at the time of admission. **The order of merit for admission shall be determined on the basis of computed marks of the candidate.**
